### Entry Form AND Liability Release

For Cowboys & Cowgirls Age 4 – 7 (50 lbs. or less)



### Mutton Bustin' Rules & Information:

1. Entry fee is **\$75.00**.
2. Open to all kids ages 4-7 years old AND 50 lbs. or less.
3. There is only space for a total of 25 participants (half to ride Friday & the other half to ride Saturday). **Each participant must be in place at the designated time or their run will be forfeited.** Conflicts will be resolved by a Rodeo Official.
4. Participants must wear a helmet and protective vest, which will be provided.
5. ALL participants must be checked-in by parent/guardian **PRIOR** to the rodeo performance they are signed up for:  
**Friday, May 24, 2024** - Check-in is at **4:00 p.m.**  
**Saturday, May 25, 2024** - Check-in is at **2:00 p.m.**  
Participants will be given a wristband upon checking in. Participants **MUST** wear the designated wristband to compete.
6. Parents/Guardians are not allowed in the chute area. Mutton Bustors will be escorted by rodeo personnel to the chutes while the parents/guardians watch from the stands. Rodeo personnel will assist the participants with their gear. A photo of the participants with their belt buckles will be taken following each run and then the participants will be escorted back to the sign up table to meet up with their parents (approximately 10 minutes after the runs are completed).
7. Due to time constraints, each participant will only be given one shot at a ride. If they refuse, their ride will be forfeited; however, they will still be included in the photo and receive their belt buckle.
8. All participants must be in approved arena attire: pants, long-sleeved shirt, and boots (or closed-toe shoes).
9. Parents/Guardians must fill out the *Entry Form & Liability Release* located on the Valley Center Stampede Rodeo website at [www.VCStampede.com](http://www.VCStampede.com). The entry form **MUST** be signed by a PARENT or LEGAL GUARDIAN and submitted with **PROOF OF MEDICAL INSURANCE** (copy of medical insurance card is acceptable).
